Chapter three was authored by Dr. David Remedios, and includes the validation of this wonderful healing from a medical viewpoint. Dr. Remedios is a surgeon, and a graduate of the New York University School of Medicine, the Baylor College of Medicine, and the University of South Florida School of Medicine. Dr. Remedios and his wife, Yvonne, have been in relationship with Dale and Jean Gentry since 1990, and have ministered with them on several different occasions. They have five children, and reside in Alexandria, Louisiana.

Chapter 1

A Healing Testimony by Jean Gentry I went for my annual mammogram on May 12, 2004, as scheduled. It was to be just another routine check-up. A few days later, my doctor called to inform me that the test results were abnormal and that I would need to return for more extensive testing. My husband, Dale, and I were preparing to leave for a ministry trip to London, England, and Madrid, Spain; so I told the radiologist that I would come in when we returned from our journey.

After our return to the United States, I went in for a second mammogram. This time, it was reviewed by two different radiologists, who both concluded that a suspicious mass had formed in my breast and that I would have to undergo a biopsy. Dale and I prayed about it and decided to have the procedure done by our trusted friend and spiritual son in Alexandria, LouisianaDr. David Remedios. Not only is he an experienced and accomplished surgeon, but he is also spirit-filled, full-of-faith, and a believer in prayer and miracles. Additionally, Dr. Remedios ministers the Word as an Assemblies of God pastor and evangelist. He has been our family physician since 1990. Dale and I were pastors in Roswell, New Mexico, at this time and even though there were many capable doctors in our area, we felt that God was leading us to make the 800 mile journey to Central Louisiana.

We arrived in Alexandria on Monday afternoon and went directly to the local hospital where the biopsy was performed. On Tuesday morning, Dr. Remedios arrived at the place where we were staying. He seemed deeply concerned. He informed us that the mass was malignant and would need to be removed immediately.

I had never suspected that the mass was malignant. During the entire time, I had such peace. I never saw myself having surgery.

He strongly recommended that I undergo surgery that very afternoon. Less than three hours later after receiving the diagnosis, I was checked into the hospital and prepared for surgery. Everything was happening so fast.

As I sat waiting in my hospital room, Don and Dianne Labro, close friends and pastors from Church Point, Louisiana, arrived to pray for me. They looked at me and asked, "Do you have a peace about having surgery this afternoon?" I replied that I had no peace about it all. They replied, "If you don't have peace about it, then maybe you shouldn't have the surgery right away." I turned to Dale and told him to call the nurse and have her remove the IV from my arm. Upon entering the room, she also confirmed that she did not have a peace about my having the surgery either and proceeded to remove the IV. We prayed with her and, as the Holy Spirit filled the room, she began to rejoice and declare that God had sent us there, on that day, especially for her. It was truly a divine appointment!

As soon as we informed Dr. Remedios of our change in plans, he agreed that if we did not have a peace, we should wait; so, instead of undergoing a massive surgery, Dale and I; our doctor and his wife, Yvonne; and Pastors Don and Dianne went out for a steak dinner. I had total, undeniable peace. They were all amazed. (stopped here)

The next morning we met with an oncologist. He only confirmed the diagnosis of the two radiologists. He told us that I needed surgery as soon as possible and that it would be risky for us to leave town before the cancer was removed. We carefully considered his professional advice, but we also knew that we had to give God an opportunity to bless us. Dale and I prayed fervently about what to do next and finally decided to travel to a resting place and spend 21 days in prayer. We drove 500 miles to Tulsa, Oklahoma, where we spent time in prayer and the Word, speaking our faith declarations, and believing God for a miracle.

Dale spent time each day e-mailing people who we are in relationship with around the world, including our home church in Roswell, New Mexico. Our friends began to stand with us, in prayer and in faith, for my healing. We received many words of encouragement and letters of faith during this time. We knew that thousands of people around the globe were standing with us. I am so thankful for our relationships.

While in Tulsa, I followed wise counsel and went to see yet another doctor, who is a leading surgeon in his field, for a second opinion. He studied the x-rays, and again we were told that the mass was a malignant tumor, and that I needed to have surgery immediately.

The next day, I told Dale that I believed that I was healed, and that I wished to return to Louisiana for a second biopsy. Dale telephoned Dr. Remedios at once, and they made all of the arrangements. We returned the following day. By this time, we had been in Tulsa praying, resting, and speaking the Word for 12 days.

We arrived in Alexandria on Monday. Dr. Remedios firmly felt that we should not leave a single stone unturned, therefore, on Tuesday morning, I went once again to the local hospital for an extensive biopsy. As they took me into the operating room, I realized that I still had incredible peace. The weight was God's, not mine.

All throughout the procedure, both Dale and Yvonne Remedios interceded for me. During that time, Dale had an open vision of Jesus. He saw the Lord, clothed in a white robe, walk into the operating room, stand by Dr. Remedios, lay His hand on me, and say, "REQUEST GRANTED!" I believe with all of my heart that I was healed at that very moment!

When the procedure was completed, Dr. Remedios came to my room and visited with me for a few moments. He had given the pathologist all of the information and testing materials. The final results would be in at approximately noon the next day. I still had my peace.

The next afternoon, in a rejoicing frenzy, Dr. Remedios and his wife, Yvonne, burst into the room where we were staying. Despite their excitement, they managed to explain that not one, not two, but *three* pathologists had examined the tissue for over *four hours* and not a single one could find a trace of any form of cancer! As they told us the wonderful news, they began to describe the reactions of the pathologists, who were so stunned that they were almost apologetic.

Dr. David and Yvonne came to my room again the following day, and we again began magnifying God for the wonderful miracle which He had performed. The four of us had a wonderful time praising and worshiping God! Jesus will always receive all the praise, honor, and glory!

After a few days of recuperation, Dale and I returned to our home in Roswell. The church in which we then served as pastors, Gateway Church, truly stood with us throughout this journey of faith. On our first Sunday back home in Roswell, with a joyful heart, I shared my healing testimony. The congregation rejoiced with us over my miracle. It was an awesome Sunday.

During our time away, our son, Rick, and our daughter-in-law, Ruth, handled the majority of the details and pastoral duties of the church. I greatly appreciate them working so diligently with us. I'm also thankful for our daughter and son-in-law, Darla and Chris Greenlee, and their church in San Jose, California, for their prayers and support.

God has now set Dale and I into a new rhythm. We no longer rush out into the day, but we have made a new commitment to spend time each morning putting God first in our lives. We spend quality time every day praying together, studying the Bible, and speaking the Word.

I will never be the same again. God is truly awesome and I thank Him every day for my miracle and for the ones which He continues to send me. God has also healed me of high blood pressure.

In closing, I would, once again, like to thank my Jesus for paying the price for my healing. I also want to thank my husband for walking with me throughout this journey. We have never faced anything so great as this in our 43 years of marriage and our 37 years of ministry, nor have we ever had such a marvelous victory in Christ. Dale's faith was strong, never wavering, never doubting. I want him to know how much I appreciate him being there for me.

Chapter 2

FRIDAY - June 25, 2004

The past several days have been challenging for both of us. We have received several reports that Jean's mammogram has shown that a suspicious mass has formed in her breast. We have prayed, and we strongly feel that we should make the 800 mile journey to be with Dr. David Remedios, a Holy Ghost doctor, pastor, and friend. We both completely trust him, and we have been in relationship with both he and his wife since 1989. Jean definitely wants to make this journey so that she will have a doctor who has tremendous faith, and who will help us walk this out . . . whatever it may be. We know that we have the option of having the biopsy done in Roswell, near home, but we are confident that this is not what God desires for us to do.

We have received a prophetic word which declares, "Jean may have a suspicious mass, but it is not malignant. Go ahead and have it checked out by a doctor you trust, but relax."

Today, I wrote this to my prayer partners, "This is the biggest giant which we have faced in these past 37 years, but WE BELIEVE GOD!"

Today, we will be preparing to make the journey to Alexandria. Our grandson, Brock, had his birthday party. Jean and I both attended.

SUNDAY - June 27, 2004

We had planned on beginning our much needed vacation today. Instead, after church, we made the drive from Roswell, New Mexico, to Argyle, Texas, where we are spending the night with our friends, Mike and Anita Nelson. Mike is CEO of Red Rock Energy. They are both joining us in prayer concerning Jean's mammogram.

This afternoon, I received an encouraging telephone call from Pastor Ron Dryden in Oklahoma City. Also, the Power Tower, which is the 24 hour prayer ministry of Calvary Cathedral International in Fort Worth, pastored by Bob and Joy Nichols, is now praying for us. They have been praying around-the-clock for almost 10 years. We now know that there is continuous prayer going up for us 24 hours a day.

MONDAY - June 28, 2004

It is raining outside. We have arrived in Alexandria, Louisiana, where we will be staying at "The Prophet's Chamber," an apartment provided by Dr. David and Yvonne Remedios for their minister patients. Jean has an appointment at 1:00 p.m. for her biopsy. It is going to be a challenging day. The radiologist visited with me, and he definitely feels that there is a malignancy. We will get the full report tomorrow. I am wrestling in my spirit, but I know that God is holding my right hand. I did not discuss this report with Jean. She seems to be at total peace.

Pastor Bob and Mary Ellen Shafer from Kingfisher, Oklahoma, called to let us know that they are praying for us. Dan Griffin from Red Rock Energy in Fort Worth called later to say the same.

Jean is such a healthy woman, and has never had a surgery, not even a cavity. However, we know that it is an attack from Satan and our faith is strong. Dr. Remedios feels that Jean should undergo the operation immediately . . . that we should not allow this to stay in Jean's body. We approved and he scheduled her surgery for 4:00 p.m. today.

We called our family and e-mailed our friends, asking them to pray. Two of our friends, Dr. Remedios's wife, Yvonne, and evangelist Tina Welch arrived at "The Prophet's Chamber" to pray for us before we left for the hospital. We had an intense prayer time, as Tina continually prophesied, "THIS WILL BE AN OVERWHELMING VICTORY!"

Don and Dianne Labro, pastors in Church Point, Louisiana, were also contacted and they asked to come and be with us. We gratefully accepted their offer. They arrived at the hospital and we prayed for Jean. Suddenly, as we were waiting for her to be taken into surgery, there was a divine interruption. Even though she had gone through the entire preparation procedure and was waiting to be wheeled into the operating room, Jean knew that she had no peace about having this done today, so we postponed the surgery. While she was waiting to be released from the surgery room, we prayed with the head nurse, who said that we were sent by God, specifically on that day, to minister to her.

After leaving the hospital, we decided that we needed to leave town and go on a 21 day prayer journey. Dr. Remedios is in complete agreement.

Jean and I, Dr. David and Yvonne Remedios, and Pastor Don and Dianne Labro went out for a steak dinner. Jean now has such a perfect peace about the situation. We called Don and Kay Couch in Tulsa, who have offered us their guest home. They said that everything was ready for our arrival.

Before we went to bed, we received a phone call from our son, Rick, who told us that our daughter-in-law, Ruth, as well as our grandchildren had been in a dangerous car accident, but they were not seriously injured. This is just a confirmation that all of this is another satanic attack on our family, but I declare that Satan will not prevail. There must be some incredible victories ahead.

He informed us that we have two options: either a modified radical mastectomy or a lumpectomy with 30 radiation treatments. In his opinion, the supernatural is not to be considered, but we believe God. The oncologist has pleaded with us not to leave town without the surgery. He also stated that it would be impossible for us to go away and rest with this hanging over our heads, but evidently he does not know the God of peace, Jehovah Shalom, like we know Him. We are certain that God is going to give us supernatural rest, and our next step is going to be to receive it.

My love for my wife, whom I married when we were just teenagers, is overwhelming. I wept until I thought that my heart would burst today, just thinking about how much I love and care for her. She has been my faithful companion for 43 years. We do almost everything together. I will stand with her and, together, we will see this through to victory.

We received these encouraging words from Pastor Bernie and Nan McLaughlin from Kilwinning, Scotland: "I seem to remember God taking care of this in the past, at Calvary Cathedral in Fort Worth. (Bernie prayed for Jean and she was healed in 1997 when she was scheduled for gallbladder surgery.) Stay specific. Stay focused. Quietness and confidence shall be your strength . . . standing in agreement."

THURSDAY - July 1, 2004

This is the first day of our 21 day prayer journey. We believe that this is God's ordained will and that God delayed the surgery so that we could have a time of supernatural rest.

Neither of us can remember the last time we were this exhausted. We returned from ministry in England and Spain a few days ago, and since then, our schedule has been extremely hectic. This was supposed to have been our vacation time . . . the vacation and rest that we so desperately needed.

We received a phone call from our friend Tony Miller, telling us to stay in peace, and that the God of peace, Jehovah Shalom, would shortly crush Satan under our feet. He said that he would send us his healing CD.

Our prayer is, "FATHER, WHAT DO YOU WANT US TO DO IN THE MIDST OF THIS SITUATION?"

Today, we mapped out our strategy. I am to turn aside and minister to my wife. Oh, what a faithful wife I have! Also, during this time, we are to do nothing but rest, exercise, watch our diet closely, and spend great amounts of time in prayer and in the Word. We believe that the Holy Spirit will direct our days and guide our nights. Furthermore, we have developed an Internet prayer list of several friends in our e-mail address book. We know they will pray and stand with us in faith.

Today, I asked Jean where her faith level was, and she said that she did not see herself having surgery. She is believing for healing without surgery, so I set my faith with her faith. Everyone must find their own level of faith in which to operate. I calmly reassured her that I was standing with her for a total healing. We have also purposed in our hearts that we will not be afraid.

God has spoken to us from 1 Kings 19, concerning Elijah. When he was being attacked by demonic forces in greater measures than he believed he could handle, the angel of the Lord had him lay down, rest, and eat. Only then did he receive supernatural energy and provision. Right now, we believe that we are entering into a supernatural rest.

Today, we also received a variety of health products from our longtime friends, Bill and Sue Hart. Bill is the founder and Chief Executive Officer (CEO) of Kingsway in Austin, Texas. Jean and I have both used their health products over the years, particularly the Alkaline Coral Calcium. God has put it in our hearts that, during this time, we are to watch what we eat very carefully, and to take vitamins and minerals to build up our physical bodies.

I have been reading Joyce Meyer's book, *The Word, the Name, the Blood*. She wrote that each time we are in a battle, we need to have a battle strategy. We are continually checking up on ourselves to make sure that we are walking in love and forgiveness. We desire for there to be nothing which might hinder our prayers.

Pastor Keith and Tracey Johnson of Saskatchewan, Canada, gave us an encouraging word, saying, "Be of good cheer! The battle is the Lord's, and the victory is ours, so fight the good fight of faith, and lay hold of the healing which Jesus purchased for you."

MONDAY - July 5, 2004

Tremendous spiritual warfare is being waged. I called my pastor, Bob Nichols, to talk with him about Jean, before he leaves for vacation tomorrow. We talked about healing . . . the practical aspects and the supernatural aspects. He advised me to follow our peace. He declared that whatever route we take - whether it be to undergo surgery, to wait for a supernatural miracle, or to turn to an alternative form of medicine - whatever our journey, it must be radical. We must take the radical route. He also said that "no problem is as great as it is when it comes your way." God is teaching us how to have more compassion on others in their time of need. This will be a profitable journey, and we are standing on our rhema word, "you have sown healing and miracles into thousands, and now you will reap healing and miracles."

Tony Miller's healing CD and Godfrey Birtill's new victory CD which we received today have been a blessing. The Lord has declared to us that we will *pursue*, *overtake*, *and recover all!*

Today, He has given us specific instructions on how we should use "the sword of the Spirit" during this particular time.

Jean and I are continuing to get supernatural rest. Today, we spent time praying with our hosts and longtime friends, Pastor Don and Kay Couch.

We are asking God to look in His book of remembrance and to find Jean's name and to, once again, review how faithful she has been during our 37 years of full-time ministry. She is such a wonderful wife, mother, and grandmother. Jean has been an inspiration to so many people around the world.

One example of her influence was demonstrated in a letter which she received today from our daughter-in-law, Ruth Gentry. She wrote, "I woke up this morning and just couldn't get you off of my mind or out of my heart. I spent most of the morning praying for you, and mostly thanking God for your healing. I just wanted to let you know that I would do anything for you. You know, Mom, there aren't many women that I can say that I look up to, admire, and respect; but you're at the top of the list. E-mails are coming in daily from our friends and prayer partners around the world, who continue to give us godly reports, prophetic words, scriptures to stand on, and much needed encouragement. Thousands of faith-filled believers are standing with us and praying daily for Jean's healing. We are truly blessed!

Pastor Lawrence Neisent from Oklahoma City, Oklahoma, called today to say that God was going to move in a radical way on our behalf. The key word was "radical." I have been hearing that word in my spirit, as well.

Hugh Henderson in Dundee, Scotland, told me that, as a prophet, I was to prophesy over my wife. This word has strongly registered in my spirit, and I am believing God for words from the Lord concerning Jean's healing.

This word was also received from Pastor Paul and Perrianne Brownback: "Last night, we had a soaking night at church. We soaked some for Jean . . . taking in healing scriptures for her." These words were very encouraging to both of us.

We left Tulsa and began the long journey back to Alexandria, Louisiana. On the way, we had yet another demonic attack from Satan, but we overcame! When we arrived, we spent some time with Dr. David and Yvonne Remedios, discussing the next day's procedure. After he explained all of the medical details to us, we spent some time together in prayer.

Pastor Don and Sharon Clowers from Dallas, Texas, wrote, "We are standing in agreement and believing that you are on the other side."

I hurried back to "The Prophet's Chamber" and shared these words with Jean, and I, once again, asked her if this was the next move she wanted to make. Chapter 3

In Jean's particular case, the mass was classified as a mammographic lesion, which means that the mass was not palpable . . . it could not be felt. I recommended that she undergo a formal needle localization under mammographic guidance. This is an x-ray procedure performed by a radiologist, in which he inserts a guide wire into the area in question . . . the same area where the needle had shown carcinoma before. This marks the questionable area with a "marker" of sorts. Then, I, as the acting surgeon, would take the patient into the operating room to perform a formal open biopsy with all of the tissues surrounding the tip of the wire.

I brought Jean into the operating room and, just as I have done many times throughout my medical career, performed the above described biopsy. I removed the specimen and sent it to the radiologist so that it could be x-rayed. Later, the radiologist called and said that I had successfully excised all of the area in question and that the specimen was being submitted to the pathologist for examination. I telephoned the pathologist from the operating room, and he assured me that, by 10:00 a.m., I would have the final results of the pathology report.

The next day, I began to grow impatient as it was already noon, and I still had heard nothing from the pathologist. Assuming he was running somewhat behind schedule, I called again at 2:00 p.m. He seemed apprehensive, and explained to me over and over again that he could not find any area of cancer in the specimen and that he was sending for the original slides. He was also going to send samples to the LSU Laboratory at the University here in Alexandria for a second opinion, but it was all to no avail.

My wife, Yvonne, and I again made our way to the door of "The Prophet's Chamber," but this time we were rejoicing as we went. We joyfully told them about how the pathologists had been searching and searching and were unable to find a single trace of cancer in the entire specimen.
